

Millet conclave 2022 is being organised as a curtain raiser prior to the International Year of Millet 2023. The millets farmer producers associations (FPOs), processors and startups are participating in the two-day conclave 2022 being organised jointly by Atal Innovation Mission, UAS and NABARD.

Over the past years due to the SELCOs intervention, the implementations of DRE based millet post harvest processing units are helping the farmers and the communities to get better price for the processed millet as well as increasing the nutritional security through increased consumption of processed millets. The SELCO foundation participated in the event where we demonstrated and showcased the DRE based millet post harvest processing technologies, in order to create awareness among the key stakeholders like farmers, FPOs, MFIs, NGOs, Universities and other concerned stakeholders in the millet value chain.



Evolving support systems for decentralized millet processing

Purpose of the discussion is to integrate the experiences across the country and come up with policy asks along with suggestive strategy towards the discussion in national level convention on "Millet for Millions".



Key participants:

SELCO foundation team, Millet machinery manufacturers (Bhavani, Perfura, Transfarm technologies, and Manyam grains etc.), CSOs (Wassan, The millet foundation, Dhan foundation)



- Focus towards the gender inclusive decentralised solution is the need of the hour, also making machines more aspirational, user friendly and energy efficient
- Asset based financing is crucial create local ownerships
- We need a focused group with skill set and expertise to work on decentralisation of millet processing units. How do we bring machines which are low cost, low energy consuming, easy to use by the community, 100 kg to 2 tonnes per day should be the capacity
- Developing a team of local trainers and cadres for providing the technical service support to the local processing units.
- R&D: Technological development, identify the opportunities and design the machines as per community needs. We need to set up a machinery research and development centre for reaching out to community needs and getting immediate support on technical issues. Presently, it is just based on the personal relationship with the technical and research institutes which needs to be in public partnerships
- Defining the standard of the machine has to be done by people who are within the industry along with the research and academia people. So that the standard becomes more robust.





Theme:

Focus was on finding ways to make millet affordable and accessible while benefiting millions of farmers and rural entrepreneurs through people-centric approaches to millet cultivation and processing establish productive and resilient rainfed agriculture.
