provide affordable, accessible and good quality health care. Reliable and affordable

electricity access, alongside appropriate medical and electrical appliances contribute to increased efficacy and positive impact of healthcare provision. The need for energy is crucial when it comes to storing vaccines, using medical equipment such as baby warmers, suction apparatus and lighting especially during deliveries, powering diagnostic services and accessing basic lighting and communication for regular surgeries. Sustainable Energy when combined with efficient medical and electrical technologies helps to democratize the delivery of health services. As the country is putting their best foot forward in preparing to handling pandemic like COVID 19, SELCO Foundation along with philanthropic organisations and NGOs have partnered with the Ministry of Health, Government of India and NHSRC in one of the largest programs for upgrading and empowering public health facilities with solar energy and efficient medical equipment across India. The larger goal of the project is to strengthen 25,000 public health with Decentralised Renewable Energy and efficient medical equipment in the next 5 years.

Due to improved reliability and access to clean energy, primary outcomes of the program include:

- Increase in Patient footfall, deliveries, types and number of services provided at the centre
- Reduced out of pocket expenditure and transaction costs on accessing basic health services for poorer communities in the selected region
- Improved staff comfort and retention levels especially in remote and vulnerable contexts
- Reduction in cost per patient healthcare provision at a state level
- Improved climate resilient and reliable access to critical health services for last mile populations.

Goal and Objective:

The purpose of this Terms of Reference (ToR) is to outline the scope and objectives for conducting **detailed site assessments, data collection, and documentation of solarrelated issues** in solar systems installed at **public health facilities across the districts of Karnataka**. This exercise aims to evaluate system performance, identify operational challenges, and gather critical information to support effective maintenance, issue resolution, and long-term sustainability of the solar infrastructure under the *Soura Swasthya* program.

Scope of Work -

Project Background

The SELCO Foundation, in partnership with the National Health Mission (NHM), Government of Karnataka, is working towards sustainably powering 5,000 government



health centres across the state. Under the **Energy for Health / Soura Swasthya** program, approximately **2,311 solar systems** have been installed to date.

However, data for some health facilities remains incomplete, and there is a need to realign and strengthen maintenance efforts to ensure continuous system functionality.

To enable effective management of the existing solar power systems installed across approximately 159 health facilities, a comprehensive assessment and documentation exercise is proposed. This will involve:

- On-site assessment of existing systems
- Identification of rectification needs
- Detailed documentation of findings
- Submission of a consolidated report to the SELCO Foundation

This initiative is crucial to **maintain optimal system performance**, **address maintenance gaps**, and ensure the **long-term sustainability** of our renewable energy investments in the healthcare sector.

1. This data is essential for:

- Facilitating asset handover to the respective government authorities
- Need to **rectify solar system issues** to make them functional, which may involve repair or replacement of components.
- Planning for ongoing operations and maintenance (O&M)
- Enabling regular monitoring of the systems' functionality and performance

2. Objectives:

- Conduct physical verification of all previously installed solar systems at identified health facilities (Existing solar systems) as per the list.
- Document system specifications and current operational status.
- Create a comprehensive database of solar installations for management purposes.
- To understand and assess the solar energy scenario at the health facilities.
- To assess and identify the energy gaps at the Primary Health Centers.
- To evaluate the installed Solar PV System's conditions at the Primary Health centres including all components and functionality and to submit the technical study report along with recommended BOM and its Specifications for rectification.

3. Task and Responsibilities:

Physical Site Assessment

- Visit around 159 identified healthcare facilities with solar systems across Karnataka districts as mentioned in the list and need to visit health facilities if solar shift has occurred. Collect current information.
- Update the details into the provided excel sheet and photos in a separate drive.
- Verify the presence of solar systems at each location.
- Document if systems have been relocated from original installation sites.
- Photograph each installation (minimum 10 photos: panels, batteries, charge controller, inverter, and complete system).
- Document health facility contacts details.

Detail Site Assessment

- Conduct site visits to collect the technical details as per the Annexure Attached.
- Prepare Bill of Materials with specifications to be used at each site.
- Prepare System and Load Wiring Single Line Diagram for each category of Design for existing Solar PV system.
- Conduct Load Assessment at Sites (for the connected Solar and Non-Solar Loads).
- Carry out Physical Observation and Electrical Recording of Components.

Preparation of Detail Study Report

- Prepare Site-Wise Study Report mentioning the Components Failure and causes of System Breakdown.
- Prepare List of PHCs under each category of Solar System (Hybrid/On-Grid/Off-Grid) mentioning functional or non-functional.
- Prepare and submit a comprehensive, well-structured report of the study.
- Initial Draft Report should be reviewed before the final Submission.

Prepare final BOQ for Rectification

• Prepare a detailed solution for Solar PV system rectification (Detail BOQ-Technical Specification and Quantity for each component replacement) centre-wise.



Operational Status Verification

- Test functionality of each system component.
- Record actual power output.
- Document current usage patterns (what appliances/equipment are connected).
- Note any operational constraints or issues reported by facility staff.

4. Reporting Requirements

- Provide a comprehensive digital database in Excel format containing all assessment data
- Submit individual site assessment reports with photographs
- Prepare a consolidated report highlighting:
 - Common issues identified
 - Recommendations for maintenance/repair
 - Asset tracking information for handover purposes

5. Timeline and Coordination

- Complete assessment within [30] days of signing of the agreement.
- Coordinate visits with district health officials and facility in-charges
- Provide weekly progress updates during the assessment period

6. The essential qualification to undertake this

- The agency should have a minimum of 7-10 years' experience in providing technical services in the field of Solar PV technology.
- The agency should have expertise in performing detailed energy audits.
- The team members deployed by the agency are expected to have technical expertise in electrical/ solar solutions.
- The agency should have the ability to interact with concerned government bodies whenever required.
- Need to delegate through team representative in the geographies assigned by SELCO Foundation

Refer Terms and Condition:

1. Sub-contracting:

In the event that the Enterprise requires the services of subcontractors to perform any obligations under the Contract, the Enterprise shall obtain the prior written approval of the Foundation. Any rejection or non-performance of the subcontractor shall not, in and of itself, entitle the Enterprise to claim any delays in the performance, or to assert any excuses for the non-performance, of any of its obligations under the Contract, and the Enterprise shall be solely responsible for all services, obligations and deliverables performed by its subcontractors.

2. Quality Assurance

The data submitted to Selco Foundation should be accurate, complete, reliable and relevant. Consulting agency shall establish additional layers for data cleaning and submission.



3. Financials & Reporting

TDS will be deducted on the fixed amount as per Income Tax Act and Rate of Percentage. In accordance with the Central Board of Direct Taxes circular No. 7 of 2022 dated 30th March, 2022 in relation to the clarifications with respect to Section 114AAA of the Income-tax Rules, 1962, failure to link Aadhar number to the PAN card and/or failure by any person, who falls within the income tax bracket or otherwise, to file tax returns in relation to payment of TDS for any service (in accordance with Section 206AB and 206AA) and/or an inoperative PAN card will result in a 20% tax deduction.

4. Indemnification

Both parties shall indemnify and hold its Trustees, Directors and representative officers, employees, agents harmless from and against any and all claims, demands, actions, losses, liabilities, charges, damages, costs and expenses (including but not limited to reasonable attorney's fees) arising out of or resulting from (1) any claims arising in connection with activities undertaken by both parties in connection with the project or (2) Enterprise's gross negligence or willful misconduct or breach of any undertaking, covenant, representation or warranty contained in this agreement and/ or the actual infringement of any patent, trademark, copyrights, trade secret or any other intellectual property right of the third party.

5. Patent, Copyright and other Proprietary Rights

- i.Except as is otherwise expressly provided in writing in the Contract, the Foundation shall be entitled to all intellectual property and other proprietary rights including, but not limited to, patents, copyrights, and trademarks, with regard to products, processes, inventions, ideas, know-how, or documents and other materials which the Enterprise has developed for the Foundation under the Contract and which bear a direct relation to or are produced or prepared or collected in consequence of, or during the course of, the performance of the Contract. The Contractor acknowledges and agrees that such products, documents and other materials constitute works made for hire for the Foundation.
- ii. Subject to the foregoing provisions, all documents, reports, recommendations, documents, and all other data compiled by or received by the Enterprise under the Contract shall be the property of the Foundation, shall be made available for use or inspection by the Foundation at reasonable times and in reasonable places, shall be treated as confidential, and shall be delivered only to the Foundation's authorized officials on completion of work under the Contract
- iii. The Enterprise will treat all information given to him/her as information with proprietary value and will not disclose the same to competitors or any outsiders. The Enterprise will not at any time, except under legal process, divulge any trade or business secret relating to the Foundation or any customer or agent of the Foundation, which may become known to him by virtue of his position as Enterprise, save in so far as such disclosure shall be necessary in the interest and



for the benefit of the said Foundation and will be true and faithful to the Foundation in all dealings and transactions whatsoever relating to the said Foundation.

iv.Reports or other data that are developed specifically for the performance of this Contract shall be the property of the Foundation and the Enterprise shall deliver reports and data to the Foundation as per the milestones. Dissemination of the reports and any information from the said contracts shall be done with written approval from the Foundation.

6. Publicity, use of name & Logo of the Foundation:

The Enterprise shall not advertise or otherwise make public for purposes of commercial advantage or goodwill that it has a contractual relationship with the Foundation, nor shall the Enterprise, in any manner whatsoever use the name, emblem, logo or official seal of the Foundation or that of SELCO in connection with its business or otherwise without the written permission of the Foundation.

Observance of Law: The *Enterprise* will comply with all applicable laws, rules, regulations and statutory requirements and amendments thereof, in the manufacture and distribution of products and supplies and in providing services to the SELCO and during the term of **Agreement.**

Child Labor- The Enterprise will, its parent entities, partners or subcontractors nor any of its subsidiary or affiliated entities (if any) is engaged in any practice inconsistent with the rights set forth in the Child Labour (Prohibition and Regulation) Act of 1986, which, inter alia, requires that a child shall be protected from performing any work that is likely to be hazardous or to interfere with the child's education, or to be harmful to the child's health or physical, mental, spiritual, moral, or social development.

Forced Labor- The Enterprise will not engage in any activity that will result in forced or compulsory labor under applicable laws including the Bonded Labour System (Abolition) Act, 1976,

Abuse of Labor- Enterprise will act in accordance with applicable laws and regulations and will not violate the rights of labourers as stated in The Factories Act, 1948 and similar legislations.

Working Hours, Overtime, Wages and Other Benefits-Working hours, wages and benefits shall be provided by the Enterprise to its staff and employees in accordance with applicable laws including the Minimum Wages Act, 1948.

• **Declaration of blacklisting-** Enterprise represents and warrants to SELCO that, as on the date of signing of this Purchase Order, it is neither blacklisted/ debarred nor it is under a declaration of ineligibility by Central / State or Semi-Government Organization/Department or Institutions and Public Sector Undertakings in India and abroad Enterprise further undertakes to duly inform SELCO in the event it is blacklisted subsequent to execution of this Purchase Order.

• **Compliance with Anti-bribery Laws:** Enterprise and each of its directors, officers, employees, agents or other (collectively referred to as "Enterprise ") represent and warrant that



it shall not either directly or on behalf of SELCO Foundation give, offer, promise to offer, or authorize the offer, directly or indirectly (proxy bribing), anything of value (such as money, shares, goods or service, gifts or entertainment) to government officials, government customers, potential government customers or foreign government officials including officials of any public international organizations or officials of any political party either in India or abroad ("Officials") with an Intent to influence any act or decision in his or her official capacity Induce the Official to do or omit to do any act in violation of his or her lawful duty to obtain any improper advantage, or Induce to use such Official 's influence improperly to affect or influence an act or decision.

The Enterprise shall not provide any offering, promising, giving or receive, solicit or accept a financial or other advantage, or any other thing of value, with the intention of influencing or rewarding the behaviour of a person in a position of trust to perform a public, commercial or legal function to obtain or retain a commercial advantage.

Enterprise understands and acknowledges that any non- adherence to the warranty as stated herein above will be violation of the provisions of the Indian Prevention of Corruption Act, 1988 and other applicable laws and legislations("Anti-bribery Laws").

In addition, Enterprise agrees to promptly report to SELCO Foundation of any incident of breach or potential breach of this section.

• Compliance with Sexual Harassment of Women (Prevention, Prohibition & Redressal) Act, 2013 (PoSH): The Enterprise shall agree to adhere to the mandates prescribed under the Sexual Harassment of Women (Prevention, Prohibition & Redressal) Act, 2013, which requires all workplaces to have a Policy and Internal Committee to address complaints of sexual harassment that women may face at the workplace.

8. Termination:

Either party may terminate this contract by giving a notice in writing to the other party stating their intention to terminate the same on the expiration of Seven (7) days from the date of such notice. In addition, the Foundation may also terminate this contract forthwith in the event of any fraud, misconduct or neglect of duties on the part of the Enterprise. Any notice to be given hereunder shall be sufficiently given to the Enterprise if forwarded by registered post or by Courier Service to the last known postal address of the Enterprise and shall be sufficiently given to the Foundation if similarly forwarded to the registered office. Upon the termination of this contract and payment of the said fees due up to such termination, and payment of all disbursements and out-of-pocket expenses incurred up to the date thereof (provided the same have been incurred after obtaining prior approval), the Enterprise shall deliver all deeds, documents and paper in his possession relating to the business of the Foundation or as the Foundation shall direct, and shall continue to afford him all reasonable assistance for concluding pending matters at the date of such termination without making any charge thereof.



9. Force Majeure:

- i.*Force majeure* as used herein means any unforeseeable and irresistible act of nature, any act of war (whether declared or not), invasion, revolution, insurrection, terrorism, or any other acts of a similar nature or force, *provided that* such acts arise from causes beyond the control and without the fault or negligence of the Enterprise
- ii.In the event of and as soon as possible after the occurrence of any cause constituting *force majeure*, the affected Party shall give notice and full particulars in writing to the other Party, of such occurrence or cause if the affected Party is thereby rendered unable, wholly or in part, to perform its obligations and meet its responsibilities under the Contract. The affected Party shall also notify the other Party of any other changes in condition or the occurrence of any event which interferes or threatens to interfere with its performance of the Contract. Not more than fifteen (15) days following the provision of such notice of *force majeure* or other changes in condition or occurrence, the affected Party shall also submit a statement to the other Party of estimated expenditures that will likely be incurred for the duration of the change in condition or the event of *force majeure*.
- iii.On receipt of the notice or notices required hereunder, the Party not affected by the occurrence of a cause constituting *force majeure* shall take such action as it reasonably considers to be appropriate or necessary in the circumstances, including the granting to the affected Party of a reasonable extension of time in which to perform any obligations under the Contract.
- iv.If the Enterprise is rendered unable, wholly or in part, by reason of *force majeure* to perform its obligations and meet its responsibilities under the Contract, the Foundation shall have the right to suspend or terminate the Contract on the same terms and conditions as are provided for in this Contract.
- v.Both the Foundation and the Enterprise fully and freely intend to create an independent Contractor relationship under this Contract. Nothing herein shall be deemed to establish a partnership, joint venture, association or employment relationship between the parties. Both parties agree that the Enterprise has the right to sole and exclusive control over the manner and means employed in performing their activities under this Contract.

10. Settlement of disputes:

i.The Parties shall use their best efforts to amicably settle any dispute, controversy, or claim arising out of the Contract or the breach, termination, or invalidity thereof.

Any dispute, controversy, or claim between the Parties arising out of the Contract or the breach, termination, or invalidity thereof, unless settled amicably, within sixty (60) days after receipt by one Party of the other Party's written request for such amicable settlement, the matter shall be



referred by either Party to arbitration in accordance with the Arbitration and Conciliation Act, 1996. The venue of the arbitration shall be at Bangalore. Likewise, the jurisdiction will vest with courts in Bangalore.
